#### Welcome

Chair Marty Peterson called the meeting to order at 9:08 a.m. and welcomed Council members, staff, and guests.

#### Retirement 101

Mr. Ryan Ashcraft presented on retirement basics through an interactive URS Jeopardy game including the following:

## **Legislative Discussion on Retirement Benefits**

Mr. Dee Larsen introduced Senator Wayne Harper as the longest serving legislator, currently serving in the Senate. He asked Senator Harper to touch on retirement concerns, what happened this last legislative session, and allow time to answer questions from council members. Senator Harper stated the legislature is highly committed to making sure retirement commitments are funded and met. He sponsored S.B. 140 in the 2024 General Session, which would allow employers to pick up the public employee's portion of required retirement contributions, which did not pass this session. He will submit this bill again in the 2025 general session. He then took questions. Membership Council members enjoyed his interaction and taking time out of his busy schedule to meet and explain issues relative to policies and retirement.

Mr. Marty Peterson stated he feels that in general for public safety and fire, the employers will be picking up the additional employees' expenses.

Mr. Larry Millward expressed his thanks to all URS staff for making council members feel so appreciated and welcome at URS.
