No Need to Report IRA, Roth Contributions on W-2s



If you have employees contributing to an IRA or URS Roth IRA, it's not necessary for you to report the contributions on their W-2. URS will report the contributions to the IRS on Form 5498. Please note that the "designated Roth" account referenced in the W-2 instructions is not a Roth IRA. A designated Roth account is referring to a Roth 401(k), Roth 457 or Roth 403(b). URS does not currently offer these types of accounts.



URS Savings Plans

Higher Catch-Up Limits for Certain Age Groups Go Into Effect in 2025

Beginning 2025, active members age 50 or older may make elective contributions in URS Savings Plans up to \$23,500 per year and catchup contributions up to \$7,500.

Additionally, with the passage of SECURE 2.0, in 2025, federal law will allow active members to increase their catch-up contribution in the years they turn age 60, 61, 62, or 63 to the greater of:

- » \$10,000 or
- » 150% of the regular catch-

up amount for 2024 (\$7,500), indexed for inflation. For example, someone age 60-63 will have a catch-up limit of \$11,250 in 2025, compared to the regular \$7,500 limit for those age 50-59 or 64 and older.

This new rule goes into effect January 1, 2025. If your current payroll provider already tracks and limits contributions, including catch-up amounts, they have likely already addressed these changes.

This may directly impact your employees and your interaction

with the URS contribution report. To minimize potential excess contributions, please reach out to your payroll provider to see how they are addressing these new limits.

URS will continue to monitor excess contributions based on these new age and contribution limits to ensure that URS and its participating employers remain in compliance with federal law. However, please monitor your payroll to ensure compliance as well.
